Our Services in 2022 - 2023

- advocacy cases were delivered, supporting people with learning disabilities to deal with problems and access their rights
- people attended drop-in sessions at different venues across the city
- members took part in self-advocacy groups and gained peer support, skills and confidence
- people took part in consultation events to have their say about health, social care and other services they use
- people attended workshops and advocacy events to talk about key issues and together had a stronger voice

Why Is Our Work Needed?

People with learning disabilities continue to face extreme health inequalities and discrimination in many areas of their lives, including:

Extreme health inequalities and a shorter life expectancy than the general population

25-40%

of people with learning disabilities have mental health problems 50%

say they face extreme isolation leading to additional physical/ mental health issues

36%

say they have experienced hostility, aggression or violence from a stranger because of their learning disability 86%

of adults with learning disabilities surveyed said they want to work. Only 5.1% of those known to their local authority in England are in paid work



It is estimated that almost 6000 adults (aged 18+) with a learning disability live in Brighton and Hove.

How Does Our Work Make A Difference?

People with learning disabilities have been supported to:

73%

accessing 1-1 advocacy said they gained understanding of their situation, rights and options. 92%

of group members say that advocacy support has helped them gain confidence to speak up 87%

of young people getting 1-1 support said they had gained skills and confience to express their views and make their own choices **75%**

participants reported that groups and drop-ins helped to build support networks and reduce feelings of isolation

Carrie's Story

Carrie is a young woman with a learning disability, autism and cerebal palsy. She lives independently in a privately rented flat which was arranged by Adult Social Care and has 1-1 support every day to help with shopping, managing bills and other tasks.

Carrie was recently served with an eviction order which was a big shock. She was given 14 days to respond to a complicated legal document. The reason for the eviction is because the landlord wants the flat back, not because of any issues with Carrie as a tenant. The eviction order was hard to understand, and Carrie became very distressed. She thought she had done something wrong and was very worried about being made homeless.

Carrie contacted Speak Out for help. An advocate supported her to contact a local Housing Trust and arranged to meet with a member of their team to get some legal advice. They supported her to complete the paper work and meet the court deadline.

As a result, Carrie has been granted an extension, which means she now has more time to find alternative accommodation. Her advocate is supporting her to liaise with council housing team to secure a safe place to live, that is also suitable for her physical disability.

'I am so relieved that I'm getting help to sort this, I'm not going to be homeless and I can think about getting on with my life.'
